7.4 Precept Projects and budgeting for 2021 - 2022

Ashford Borough Council has advised that it may cease paying the concurrent function grant and the council tax support grant to parishes. Concurrent grant is paid to parishes in respect of work that parishes carry out on behalf of the borough such as litter picking. The clerk would not recommend taking on any further projects which might need funding from the precept as the budget is already close. Budget is available from the website.

7.5 Council Insurance

The council's insurance will be due for renewal in January. Zurich quote will be available by the time of the meeting and the Clerk will advise.

7.6 Grass cutting

To agree to contract Nigel Gibbs to cut the grass around the toilets and the verge along the recreation ground. Prices remain the same.

The Council has been approached by a resident and asked to assist with looking into the possibility of improving the broadband speed across the parish. Grants are available and should there be sufficient interest the improved infrastructure cost may be covered by these. The Council is playing a supporting role. A leaflet is shortly to be delivered to all residents and the council will be kept updated with progress.
